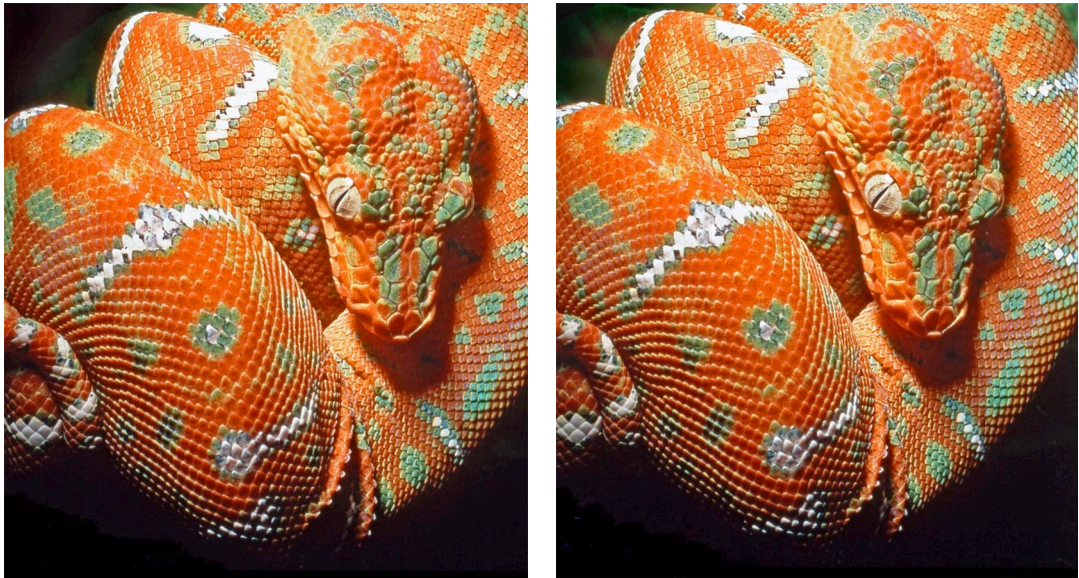


Second Pikes Peak International Digital Stereo Photography Exhibition
